The Foundation's Report

Information about the Foundation

The Right Livelihood Award Foundation is a Swedish non-profit foundation known internationally for presenting the Right Livelihood Awards to individuals and organisations offering practical and exemplary answers to the most urgent challenges facing the world today.

According to its statutes, the foundation's purpose is to present the Right Livelihood Awards; to promote scientific research, education, public understanding and practical activities which:

- contribute to a global ecological balance
- are aimed at eliminating material and spiritual poverty; and
- contribute to lasting peace and justice in the world.

The Foundation shall also support and report on the projects for which awards are presented.

The Right Livelihood Award Foundation is under the Swedish Income Tax Law (Inkomstskattelagen) (1999:1229), chapter 7, §17 liable for tax only on income from property holding. The Foundation has a so-called '90-account' (Swedish Fundraising Control) and is financed mainly by donations from individuals. It is also a member of FRII (The Swedish NGO Fundraising Council). The Foundation has a support account within the German charity GLS Treuhand and there is also a support foundation for the Award in Switzerland.

Management of the Foundation's assets

The Board decides the strategy for how the Foundation's capital should be invested. The German GLS Bank, which only offers investments approved by the bank's social and ecological criteria, manages the major part of the capital. The Foundation only invests a small percentage in stocks (2014-12-31: 10%) and a large part in bonds. The most important role of the capital is to serve as a buffer and security for the future, not to, with a high risk, yield the highest possible return.

The Foundation's assets are managed in five different ways:

886 216 SEK (previous year 866 715 SEK) is invested for five years in the Swedish social and ecological bank, Ekobanken, with a fixed interest of 2.25%.

12 868 963 SEK (previous year 13 794 280 SEK) was invested in bonds in Swedish kronor, rated AAA and Aaa, issued by the Swedish government, municipal lending institutions in Denmark, Finland and Norway, project finance institutions in the Netherlands and Germany, and Swedish mortgage lending institutions. The 2014 return on investment was 3.33% (previous year 1.64%,).

12 455 620 SEK (previous year 6 423 213 SEK) was invested in EUR in various companies with an ethical profile through GLS Treuhand. The 2014 return on investment was 3.4 % (previous year 3.4 %) in EUR.

3 525 331 SEK (previous year 2 830 392 SEK) was invested in SEB's global index based stock fund with an ethical approach. The 2014 performance was 27.2 % (previous year 23.2 %).

5 029 456 SEK (previous year 0 SEK) was invested in an office building in New Zealand. The Foundation's share is 3.5%. The first return is expected in 2015.

Since the capital is not sufficient for the Foundation to fund its activities from the return on investment, the Foundation works to raise additional donations. In our fundraising, we seek to build a platform of annual private and institutional donors to cover the costs of the year and to secure the Award for the future through capital donations, which are added to the foundation equity.

During the year, we received a few capital donations, aimed at building up the Foundation's capital to a level, which will permit us to engage in more long-term planning and where the capital would enable us to carry out a broader programme in support of our Laureates. In 2013, we received a donation from Germany – a house which we sold for 12 937 600 SEK (1 450 000 EUR). During 2014, the Foundation decided that this money should be invested in a house in Enskede, Stockholm, which will function as an office for the Foundation from April 2015, something that will also lower the monthly office costs. Capital donations are directly added to our equity. Mainly because of capital donations, the equity increased from 38 717 101 SEK to 43 389 346 SEK during 2014 – a 12% increase.

Activities

Based on the Foundation's statutory purpose, the Foundation works towards four overarching objectives:

- 1. to give out the Right Livelihood Award;
- 2. to support the Laureates;
- 3. to educate young people about global problems and solutions; and
- 4. to report about the Laureates and their work.

The Foundation's activities are designed to reach these objectives in the best possible way.

In the Foundation's strategy for 2010-2015, we have prioritised a few specific objectives to serve as milestones on the way to the four overarching objectives mentioned above:

- to increase the Award money;
- to improve the protection of our Laureates;
- to invest more in educational activities; and
- to develop our communications in order to reach a wider public with information about the Laureates.

In 2014, the total prize sum was unchanged from the previous year (2 000 000 SEK). It was shared equally by three Laureates. In 2013, four Laureates had shared the same amount. We organised an important solidarity mission to support one vulnerable Laureate. A new Right Livelihood College campus was added to the network so that we now have 7 campuses on five continents. We hired a press consultant for Africa and arranged a second regional conference for Laureates from Africa and the Middle East.

Though these new activities lead to higher expenditure – 9 849 144 SEK compared to 7 811 218 SEK in 2013 – we were able to finance this with the donations we received – 8 832 877 SEK (previous year 6 766 115 SEK) – as well as with the return from investments – 2 696 648 SEK (previous year 1 265 038 SEK). The result of the year was 1 680 380 SEK (previous year 219 935 SEK).

Major activities during the year

Goal 1: To give out the Right Livelihood Award

Selecting Laureates

Anybody can propose a person or an organisation for the Right Livelihood Award. For the 2014 Awards, we received and researched 120 proposals from 53 countries (2013: 94 proposals from 48 countries). The 12 individuals comprising this year's jury met 12-14 September to decide on the 2014 Laureates.

2014 Laureates

The new Laureates were to be announced on 25 September at a press conference to be held, as usual, at the Swedish Foreign Ministry's Pressroom. After informing the Ministry for Foreign Affairs about the fact that one of our Laureates was Edward Snowden, the Foundation was not allowed to hold the press conference there this time. The Swedish Television found out about this and published the news on 24 September, which forced us to release all the information about the new Laureates immediately. The press conference was cancelled, but an announcement was arranged at the Göteborg Book Fair on 25 September.

The Honorary Award was shared by Edward Snowden (USA) "... for his courage and skill in revealing the unprecedented extent of state surveillance violating basic democratic processes and constitutional rights" and Alan Rusbridger (UK) "... for building a global media organisation dedicated to responsible journalism in the public interest, undaunted by the challenges of exposing corporate and government malpractices." The Cash Award of 2 Million SEK was shared by Asma Jahangir (Pakistan) "... for defending, protecting and promoting human rights in Pakistan and more widely, often in very difficult and complex situations and at great personal risk"; Basil Fernando/Asian Human Rights Commission (Hong Kong, China) "... for his tircless and outstanding work to support and document the implementation of human rights in Asia"; and Bill McKibben/350.org (USA) "... for mobilising growing popular support in the USA and around the world for strong action to counter the threat of global climate change".

Award Ceremony and Laureates' programmes

The Award Ceremony took place in the Swedish Parliament on 1 December with the Society for the Right Livelihood Award in Parliament (SÄRLA) as hosts. Edward Snowden spoke to the ceremony guests via a direct video link from Moscow. During their individual programmes in Stockholm, the Laureates met, for example, the Minister for Environment, Åsa Romson (Bill McKibben), Sida's Director General Charlotte Petri Gornitzka (Basil Fernando with colleagues from the Asian Human Rights Commission), Dagens Nyheter's Editor-in-Chief, Peter Wolodarski (Alan



Rusbridger), various officials at the Ministry for Foreign Affairs (Asma Jahangir and Basil Fernando), a large number of journalists and many other valuable contacts.

The Laureates spoke at different public events organised in cooperation with the Swedish Institute of International Affairs, Kvinna till Kvinna, Church of Sweden, Kulturhuset City Theatre, Dagens Nyheter, Södra Teatern, The Association Ordfront, the Göteborg Filmfestival, the student association for documentary films Cinemondo as well as Lund University Centre for Sustainability Studies.

In connection with the Award Ceremony, the Laureates also took part in various programmes in Germany (Basil Fernando), Norway (Asma Jahangir), London (Asma Jahangir), Lund (Bill McKibben) and the 2014 Right Livelihood Lecture at the University of Zurich (Asma Jahangir).

Laureates on the impact of the Award

Edward Snowden recognised the importance of the Right Livelihood Award as "a vindication for everyone who came before to raise awareness to issues of privacy and mass surveillance." He stated that we all "have something to protect – our rights" and thanked all activists around the world for their tireless support.

Alan Rusbridger remarked that his Honorary Award stands as recognition for The Guardian's work in establishing standards for responsible "open journalism". He added that "the combination of Edward Snowden and The Guardian shows the value of journalism."

Asma Jahangir announced that the award money is going to be used to set up a web radio, to institute human rights awards in educational institutions in Pakistan and to support human rights defenders under threat. "It is an award that we share. For me, it is an honour but also an added responsibility to support victims of human rights and strengthen the support for human rights in Pakistan."

Basil Fernando said the prize money is going to be donated to the Asian Human Rights Commission, "which will use it for its work on protection of human rights". The AHRC works on providing legal assistance to victims of human rights violations and is engaged in advocacy and investigative research activities for prosecution and judicial reform in 12 countries across the Asian continent.

Bill McKibben said he would fund the work of 350.org and its partner organisations with the award money. McKibben stressed that "this recognition comes at a perfect moment after the remarkable success of the People's Climate March and as we start the strongest push yet against the fossil fuel industry and the politicians it has purchased."

Goal 2: To support the Laureates

Protection for threatened Laureates

We estimate that approximately 25 of our Laureates are threatened in their home countries for the work they do. The Foundation has developed a protection programme for these Laureates.

Ever since an attempt to murder him in the fall of 2012, Dr. Denis Mukwege (Democratic Republic of Congo, RLA 2013) has not been able to stay in his home, but has been living at Panzi Hospital where he works. Since his security situation has not improved, the Foundation decided to contribute financially towards special measures to enhance his security.

In October 2014, after the war in Gaza during the summer, the Foundation arranged a solidarity mission in support of Raji Sourani (Palestine, RLA 2013). Participants in the delegation (the Award's Founder and Co-Chair Jakob von Uexkull, former Arch Bishop of Uppsala, Church of Sweden, Anders Wejryd, Agneta Johansson, Deputy Director of ILAC and Board member and the Right Livelihood Award and RLA-Laureate Helen Mack Chang from Guatemala) travelled around Gaza observing the disaster, and engaging in discussions with politicians, representatives for various organisations and survivors. Bitte Hammargren, Swedish freelance journalist specialising in Middle Eastern affairs, also took part in the visit as an observer. Newspapers in Gaza and Sweden published articles about the visit. Raji Sourani emphasised the important role the delegation's visit played in boosting the morale of his colleagues and other human rights defenders in Gaza.

The emergency protocols, describing how we should act in an emergency situation for our most threatened Laureates, were updated during 2014.

Laureates' network

An important support that we can give our Laureates is to make sure that they meet and get to know each other. When they receive the Award, they become part of an extensive international network where they meet, exchange ideas and experiences and support each other.

From 6-9 June, the Foundation, in cooperation with Church of Sweden, arranged a second regional conference – this time for Laureates from Africa and the Middle East (the first conference took place in Bogotá, Colombia in 2013 for Latin American Laureates) where 11 Laureates from 9 difference African countries took part. Raji Sourani from Gaza could not take part since the border between Gaza and Egypt was closed and our Israeli Laureates were denied visas to Egypt. There were two days of internal meetings and one day of open meetings at the Heliopolis University for Sustainable Development in Cairo where approximately 100 individuals from various local organisations, universities and authorities took part. The Laureates emphasised that "Business as usual is not an option. We need a paradigm shift toward a diverse,



holistic, sustainable agriculture." They also called on the African Union and its members to facilitate a quicker transition to agro-ecology in Africa. On top of this, three petitions initiated by different Laureates and signed by all other participants were produced during the conference.

Some Laureates also met in smaller groups, for example at the International Convention of Environmental Laureates in Freiburg, Germany, in March, and the annual event "Projects of Hope" in Bregenz, Austria, in November, as well as at the various events organised by the Right Livelihood College (see next heading).

Several times during the year, Laureates carried out joint campaigns. For instance, 32 Laureates and World Future Council members sent an appeal to world leaders at the Nuclear Security Summit about the non-existence of "secure hands" for the handling of nuclear power/nuclear weapon technique and material. During the war in Gaza, 46 Laureates from 32 countries signed the petition "They are also our children", which was sent out with a press release on 25 July.

Goal 3: To educate young people about global problems and solutions

Right Livelihood College

The Right Livelihood College (RLC) aims to link the work of our Laureates closer to researchers working with similar issues around social justice, sustainability and development. The network builds bridges between the academic world and the practical work that change makers like our Laureates carry out around the world. Right Livelihood Laureates visit and hold lectures at the RLC campuses and students receive stipends to research issues relating to a Laureates' work. For Laureates and their organisations, the cooperation is one way to spread information about their work and inspire a younger generation of academics. All activities are financed by the university institutions themselves and information about activities is sent out to all campuses in a special newsletter.

Today, there are campuses at seven universities on five continents: Addis Ababa (Ethiopia), Lund (Sweden), Bonn (Germany), Port Harcourt (Nigeria), Valdivia (Chile), Santa Cruz (USA), and Mumbai (India – opened in May 2014). The RLC Global Secretariat moved from Malaysia (which had this role since 2009, but is no longer part of the network), to Bonn during the year.

The following activities were among those arranged by the Right Livelihood College:

- A master's student from Lund started fieldwork together with René Ngongo (RLA 2009) in the Democratic Republic of Congo. Another master's student is analysing Judge Weeramanthry's (RLA 2007) work in Sri Lanka.
- The Bonn Campus started financing a PhD student who, together with Hans Herren (RLA 2013) and his organisation Biovision, will do research on

- "Productivity and Sustainability of Ecological Organic Agriculture Systems in Kenya".
- The Campus in Addis Ababa worked on a book about the 5 Laureates from Ethiopia.
- From 24-29 May, the Bonn Campus organised a workshop "Mobilisation for change: Participatory research and the empowerment of the marginalised" with three Laureates participating.
- From 28 June-3 July, the Bonn Campus arranged a workshop "Media and Development: From Individual Participation to Mass Moblisation" in cooperation with Deutsche Welle Global Media Forum, where Amy Goodman (RLA 2008) participated.
- On 4 July, the RLC Campus in Valdivia arranged a lecture with Juan Pablo Orrego (RLA 1998).

Also, 130 educators and teachers in training learned how to integrate topics such as ecology, social justice and peace studies into the classroom at a conference at the University of Kassel, Germany, which cooperates with the RLC. Three Laureates contributed with their ideas and experience.


Exhibition

The Vasa museum deputed one of their staff members to develop an exhibition about our Laureates aimed to inspire young people to action. The exhibition, which was financed by Church of Sweden, was completed during the summer and was shown at the Göteborg Book Fair in September and later at 'Kyrkans Hus' in Uppsala. During 2015, it will travel around Sweden to various venues.

Goal 4: To report about the Laureates

Presswork

In order to better reach out with information about our Laureates to the media, we extended our press team with one more press consultant – for Africa. The other consultants cover Sweden, the German-speaking part of Europe, South Asia and Latin America. The global presswork resulted in approximately 4500 articles during the year. We buy the statistics and daily reports about our press coverage from Meltwater.



There was a good interest for this year's Laureates with most focus on Edward Snowden (where the other Laureates were often mentioned as well). In Sweden, articles about the Award were published on approximately 450 websites, most of them around the announcement and the Award ceremony.

High quality articles were published by Swedish Dagens Nyheter and Svenska Dagbladet. Several longer reports were sent on the Swedish Radio and the Swedish Television (for example Gomorron Sverige and Aktuellt). There was also good media coverage in the Laureates' home countries and internationally. BBC Impact and the Spanish newswire EFE interviewed Asma Jahangir, and German Deutsche Welle interviewed Basil Fernando in relation to the demonstrations taking place in Hong Kong at the same time as the announcement of the award. German Süddeutsche Zeitung published an op-ed by Basil Fernando, and AP, AFP and Reuters wrote longer pieces on the Award and the new Laureates. Several TV stations filmed the Award Ceremony, among them two from Pakistan. International media reported extensively about Snowden's video speech in the Swedish Parliament.

Over the year, we sent out 22 press releases (more region-specific ones than last year).

During the most intense phase of the conflict in Gaza in the summer, two op-eds by Raji Sourani (RLA 2013) were published – in Svenska Dagbladet (an article which was also published in The Mail and The Guardian in South Africa) and Dagens Nyheter – as well as a longer interview in Süddeutsche Zeitung. The solidarity mission to Gaza in October gave good press results in Sweden, with several articles in four major newspapers such as Svenska Dagbladet. The mission resulted in over 40 articles being published on the Internet.

In Switzerland, the project "Solutions-based Journalism" was launched in cooperation with Ashoka. The project aims to take up positive stories in mainstream media. This lead to the following press coverage:

Web-based communication

We used the website and social media to regularly inform about the Laureates and their work. The number of visitors to our website was 10 000 in August (lowest) and 18 000 in September (highest) (2013: 13 000 in August and 22 000 in December. At the end of the year, we had over 8 000 followers on **Facebook** (2013: 6 500 and 2012: 5 000). In total, we reached almost 30 000 individuals on Facebook in September (2013: 27 000). Over 1 500 individuals followed us on **Twitter** (2013: 950 and 2012: 500) with a clout number of 61 (of 100 possible – same as 2013). Our **YouTube** channel was used over 22 000 times during the year (2013: 21 000). In 2014, we added 15 new films and we now have 138 films there.

Eight Newsletters in English were sent out to all who have signed up for it on our website (2 289 persons). In the Newsletter, we inform about our Laureates' stories, joint campaigns and about the Foundation's new projects.

Improving the knowledge about the Award in Sweden

The Foundation is aiming to make the Award even better known in Sweden. Much of this work has in the past few years been done in cooperation with Church of Sweden. During 2014, we participated in the Almedalen Week where Amy Goodman (RLA 2008) recorded and aired her show 'Democracy Now!' live from Visby on 2-3 July, and where she interviewed among others the Arch Bishop Antje Jackelén, several Swedish politicians and representatives from Swedish civil society. Swedish Radio interviewed Goodman, which was broadcast live for about 30 minutes. At the Göteborg Bookfair, we presented our new exhibition 'who cares!' about the Laureates and during the Human Rights Days in Umeå, we arranged a poetry slam in cooperation with Church of Sweden where a representative from the Poetry Festival in Medellín, Colombia (RLA 2006) spoke about poetry as a tool for peace.

Illis Quorum to Jakob von Uexkull

The Founder of the Right Livelihood Award, Jakob von Uexkull, received the Swedish government's highest reward, *Illis Quorum* ("For those whose achievements make them deserve it"), from the Minister for Environment Lena Ek on 28 August for "ground-breaking work to highlight and honour those who provide solutions for issues related to the environment, peace, human rights and poverty reduction."

Governance and Administration

Board

The Board of the Right Livelihood Award Foundation consists of six members from Sweden, the United Kingdom and Germany. There were no changes to the Board during 2014. The Board held its meetings on 16 May in Stockholm and 11 September in Sylt, Germany. Board members do not receive any remuneration for their work on the board. In certain cases, they receive honoraria for work related to the selection process, support to Laureates and fundraising, which is carried out in addition to their responsibilities as board members. Staff

SUPPLEMENTARY INFORMATION

Accounting Principles

Applied accounting and valuation principles are in accordance with the Swedish Annual Accounts Act (Årsredovisningslagen), statements and general advice by the Swedish Accounting Standards Board (Bokföringsnämnden), and FRII's guidelines.

Receivables

Receivables are valued at the amount with which they are expected to be settled.

Financial Fixed Assets

The Foundation's securities are valued at the market value at the balance sheet day. Realized and unrealized changes in value are accounted for in the income statement under financial items.

Taxes

The Right Livelihood Award Foundation is under the Swedish Income Tax Law (Inkomstskattelagen) (1999:1229), chapter 7, §17 liable for tax only on income from property holding.

Donations

Donations are accounted for in the period in which the donation is handed over and then at actual value. Donations other than in ready money are valued at market value at the date of donation.

Capital donations are donations aimed at building up the Foundation's capital to a level where the work can be planned more long term and make possible a broader work for the Laureates. Capital donations are accounted for directly to equity.

Purpose determined donations and grants are initially accounted for under a separate item under equity and are transferred to income as the activities financed by the donation or grant are carried out.
