REPORT OF ACTIVITIES 2019

"The purpose of the Foundation shall be, by presentation of the Right Livelihood Awards, to promote scientific research, education, public understanding, and practical activities which:

- contribute to a global ecological balance;*
- are aimed at eliminating material and spiritual poverty; and*
- contribute to a lasting peace and justice in the world.*

The Foundation shall also support and report on the projects for which awards are presented."

(Statutes of the Right Livelihood Award Foundation)

The Foundation is under the supervision of the County Authority of Stockholm and the Swedish Fundraising Control and is financed mainly by donations from private individuals. It is also a member of The Swedish Fundraising Council (Giva Sverige). The Foundation has a support account within the German charity GLS Treuhand and there is also a support foundation for the Award in Switzerland. The Right Livelihood Award Foundation is under the Swedish Income Tax Law (*Inkomstskattelagen* - 1999:1229, chapter 7, §17) liable for tax only on income from property holding.

The Foundation's activities are designed in a way as to carry out the purpose of the Foundation in the most effective way. In its strategy for 2015–2020, the Foundation has defined *specific objectives* for the five-year period. These are listed under each area in the text below. The Foundation will decide on a new strategy for 2020–2025 in September 2020.

Management of the Foundation's assets

Specific objectives until 2020:

- Successful capital management.
- Accounting and financial reporting remains as impeccable as it is today

The Board decides the strategy for how the Foundation's capital should be invested. The German GLS Bank and GLS Treuhand, which only offer investments approved by the bank's social and ecological criteria, manage a significant part of the capital. The most important

role of the capital is to serve as a buffer and provide security for the future. It is not to be used for high risk investments of any kind.

In 2015, the Foundation acquired one part of a semi-detached house in Gamla Enskede, Stockholm. It has since been used as an office for the Foundation's Stockholm-based staff and also as a place to stay for visiting guests of the Foundation ("The Right Livelihood House"). In 2017, the Foundation acquired the other part of the house, which was renovated during the first part of 2018 and has since been leased to the International Legal Assistance Consortium. Further renovations were undertaken in both parts of the house during 2019. Taken together, both parts of the house represent just over 40 % of the Foundation's assets.

The Foundation's other assets were at the closing day managed in four different ways:

20 938 523 SEK (previous year 16 652 942 SEK) is invested in EUR through GLS Treuhand in various companies with ethical business models. The rate of return was 3.0 % expressed in EUR (previous year 3.0 % in EUR).

906 156 SEK (previous year 906 156 SEK) was invested for five years in the Swedish social and ecological bank, Ekobanken, with a fixed interest of 0.75 %.

1 000 000 SEK (previous year 1 092 000 SEK) was through GLS Bank invested in bonds in Swedish kronor rated AAA issued by a German project finance institution. The return on investment was -0.35 % (previous year -0.12 %).

3 730 539 SEK (previous year 4 120 925 SEK) is, together with other investors, invested in an office building in New Zealand. The Foundation's share is 3.5 %. The yield was 7.5 %, expressed in NZD (previous year 7.0 %).

Previous year 4 168 154 SEK was invested in SEB's global index-based fund with an ethical approach. This investment was sold in 2019. The performance was 20.4 % (previous year -1.9 %).

Fundraising

Specific objectives until 2020:

- One significant capital donation/bequest per year.
- Significantly widened private donor base.

- One new major donor per year.
- The Executive Director is only responsible for 20 biggest donors and other team members responsible for the other donors.
- Cooperation with Swiss Development Cooperation continued and Swedish government funding added.
- Geneva Circle of Friends (major donors) established.
- Efficient integration of the Grassroots Foundation (see below).

Since the return on investments are not sufficient for the Foundation to fund its activities, the Foundation works to raise additional donations. In the fundraising, the Foundation seeks to increase annual donations to cover the costs of the year and to secure the Award for the future through capital donations, which are added to the Foundation's capital.

During the year, the Foundation received four capital donations (previous year, two). See also "Supplementary Information".

Mainly because of capital donations, the equity increased from 57 670 187 SEK at the end of 2018 to 77 055 794 SEK at the end of 2019 – an increase by 33.6 % (previous year 0.1 % increase).

In 2015, the Foundation received a capital donation in the form of shares in the German Grassroots Foundation gGmbH, with a value of 500 000 EUR, where the total declared capital value of the shares was 501 000 EUR. The Grassroots Foundation is a philanthropic foundation. Its assets were valued at 18 373 000 EUR on 31 December 2019. Grassroots' income is used to fulfil Grassroots' statutory purposes and will not yield any return, and there is no controlling influence for the Right Livelihood Award Foundation. Therefore, consolidated accounts are not submitted.

Activities

To fulfil its statutory purpose, the Foundation works towards four overarching objectives:

1. HONOUR: to present the Right Livelihood Awards;
2. SUPPORT: to support the Laureates;
3. EDUCATE: to educate about global problems and solutions; and
4. INFORM: to report about the Laureates' work.

In working towards these objectives, the Foundation's expenditure was 32 669 495 SEK compared to 19 786 904 SEK in 2018. Donations received were 29 582 200 SEK net compared to 18 321 774 SEK net in 2018 and the return from investments was 1 926 619 SEK compared to 1 130 564 SEK in 2018. The result for the year was -224 060 SEK compared to +1 869 SEK in 2018.

Major activities after the end of 2019

In light of the outbreak of Covid-19, the Right Livelihood Award Foundation is monitoring the developments closely and takes steps to minimise and, whenever possible, eliminate the impact on the Foundation's operations. The Foundation follows the guidelines from the Swedish and Swiss Public Health Authorities, WHO and ECDC (European Center for Disease Prevention and Control), which has resulted in the postponement of two major international conferences that were planned since one year back, and where the Foundation still had to pay for certain unutilised services for already booked flights and hotel nights. All staff work from home since mid-March. To date, the Foundation has not noticed any significant impact on donations due to COVID-19.

Major activities during the year

Objective 1: HONOUR

The Right Livelihood Award shall be given to courageous people solving global problems, with the aim of making their work better known and inspiring people to get involved in activities aimed at building a more just, peaceful and sustainable world. The decision is based on a *selection process* that involves thorough research and evaluation of nominations from all over the world. The Foundation organises an Award presentation and a useful programme for the Laureates, lasting for several days.

Specific objectives until 2020:

- The selection process is robust and highly professional and brings out engaging and deserving Laureates with a high impact while avoiding mistakes.
- The jury has a large and diverse pool of candidates to choose from and can concentrate its choice on the message it wants to send in the given year.
- The Right Livelihood Award Foundation remains "ahead of the curve" thematically.
- A continued high quality of our Award presentation in Stockholm and a professional felicitation ceremony in Geneva.

- More high-level attendance at these events.
- The Award and the two annual events in Stockholm and Geneva are highly recognised and get attention in Sweden, Switzerland and internationally.

Selection of Laureates

The Right Livelihood Award follows an open nomination process, where anyone can suggest an individual or organisation for the Award. In 2019, our research team received and researched 110 nominations (2018: 107), which were then considered by the jury. The Foundation made an extra effort to receive more nominations for female candidates. The nominees, where 39 % were male (2018: 57 %), 29 % female (2018: 20 %), and 32 % organisations (2018: 23 %), came from 51 different countries (2018: 51).

The 2019 Laureates were announced at a press conference at the Swedish Ministry for Foreign Affairs' International Press Centre on the 25th of September. All four recipients received a cash prize.

The recipients of the four Awards were human rights defender **Aminatou Haidar** (Western Sahara) who received the Award "for her steadfast nonviolent action, despite imprisonment and torture, in pursuit of justice and self-determination for the people of Western Sahara"; public interest lawyer **Guo Jianmei** (China) who received the Award "for her pioneering and persistent work in securing women's rights in China"; climate activist **Greta Thunberg** (Sweden) who received the Award "for inspiring and amplifying political demands for urgent climate action reflecting scientific facts"; and the indigenous leader **Davi Kopenawa together with the Hutukara Yanomami Association** (Brazil) who received the Award "for their courageous determination to protect the forests and biodiversity of the Amazon, and the lands and culture of its indigenous peoples".

The 2019 Laureates' Programmes and Award Presentation

Greta Thunberg was unable to attend the programme due to her traveling back to Europe from North America by boat with a focus on her active participation in the COP-25 meeting which was moved to Madrid, Spain from Santiago, Chile. Neither could **Guo Jianmei** take part in the programme and the Award Presentation in Stockholm.

The week-long programme for new Laureates started in Berlin, where **Aminatou Haidar** had meetings with, among others, former Federal President Horst Köhler and the Federal Government Commissioner for Human Rights Policy and Humanitarian Aid, Bärbel Kofler. Haidar spoke at a meeting with parliamentarians and other invited guests, in total around 50 participants, in the Bundestag, had dinner at the Swedish Ambassador's residence, and spoke at an event at the Nordic Embassies with around 80 guests. Haidar then travelled to Zurich,

where she spoke at the Annual Lecture for a full university aula in cooperation with the University of Zurich.

Aminatou Haidar and **Davi Kopenawa**, together with representatives of **The Hutukara Yanomami Association**, then met in Geneva for a two-day programme. The by now traditional celebration of new Laureates at Maison de la Paix, open to the public and arranged in cooperation with The Graduate Institute of International and Development Studies, included speeches and music performances and was attended by over 400 guests. The event was supported by the Canton of Geneva, with guest speakers from **Survival International** (international organisation, Right Livelihood Award 1989), the American Association of Jurists, International Bridges for Justice and *Lycéens Unis pour Demain*. The introductory remarks were given by Ms. Kate Gilmore, United Nations Deputy High Commissioner for Human Rights.

Both Laureates held a meeting with the UN Deputy High Commissioner for Human Rights, Kate Gilmore. **Kopenawa and the Hutukara** representatives also attended a meeting with the United Nations Human rights Office of the High commissioner, OHCHR, Brazil Desk and the office of the Special Rapporteur on the implications for human rights of the environmentally sound management and disposal of hazardous substances and wastes. They also met with Anita Studer of Association Nordeste and the Director of the Conservatoire et Jardin Botanique de la Ville de Genève (CJBG), Dr. Pierre-André Loizeau, followed by a tour of the gardens and their seed vault. **Haidar** met with the office of the UN Special Rapporteur on Human Rights Defenders, and the Protection Head of Sector for Africa of the International Committee of the Red Cross.

In Stockholm, the Laureates received pro-bono advice for their speeches from TEDx consultants. **Haidar** spoke at an event at Medelhavsmuséet, arranged in cooperation with Emmaus and nine other Swedish organisations with a focus on the situation around Western Sahara, attended by approximately 40 participants. Together with Forum Syd, Greenpeace, Afrikagrupperna, Emmaus Stockholm, Latinamerikagrupperna, FIAN Sverige, Jordens Vänner, Amazon Watch Sverige, and Fossil Free Sverige, a lunch seminar with **Haidar** and **Kopenawa** with a focus on how Swedish pension fund money is affecting the work of the two Laureates was organised. Over 100 participants attended the seminar and the event was also live streamed on Facebook, reaching over 2090 individuals, with 55 sharings, comments etc. The Laureates were invited for lunch by two of the Deputy Speakers of Parliament, followed by a seminar in the Swedish Parliament's Second Chamber with approximately 250 participants, arranged in cooperation with SÄRLA (Association for the Right Livelihood Award in the Swedish Parliament). **Haidar** and **Kopenawa** spoke, two activists from Fridays for Future were interviewed on stage and four parliamentarians posed questions to the speakers.

The 40th Award presentation was held on 4 December at Cirkus after a dinner with specially invited guests. For the first time, the Award Presentation was open to a wider public and attracted over 1200 guests. It was broadcast live by the Swedish Newspaper Expressen on their website. The Founder of the Award, Jakob von Uexküll, was celebrated. Miriam Bryant, José Gonzales and Ane Brun performed together with a sinfonietta conducted by Hans Ek. Around 75 professionals (including a scenographer, light designer and stage manager) helped realise this project on and back stage – all of them working for a reduced compensation. This extensive event was very much supported and appreciated by partners. The advertising agency, Momentum, supported the Foundation with a communications campaign around the ticketing, and the company Tre Kronor managed to secure media sponsorships with the Swedish daily newspapers Dagens Nyheter and Expressen.

Impact of the 2019 Award

Davi Kopenawa and the **Hutukara Yanomami Association** expressed how important it was to receive the Award to spread awareness of the situation for the Amazon and its indigenous peoples and keep the attention of politicians and policy makers worldwide in order to protect their land and their safety. They were impressed by the interest and attention that the Award is capable of mobilising in Europe and internationally through social media and press, and are happy about the continuous support and cooperation.

Guo Jianmei was honoured by the Award and the recognition it gave to the many years of dedicated work by her team and network of public interest Lawyers across China. In her acceptance speech, she said: "This Right Livelihood Award recognises and acknowledges the efforts of my team and me to uphold women's rights and the rule of law in China for the past 25 years. Currently, pro bono legal work in China is facing enormous challenges. This award serves as an encouragement and motivation".

Greta Thunberg was already before receiving the Award continuously meeting celebrities and international media. Still, according to herself, the recognition reinforces her legitimacy at the international level and can assist to further attract international attention to what scientists say about the climate crisis. The Award money was used to start the *Greta Thunberg Foundation* which will focus on activism around global climate, environment, mental health, as well as human and animal rights issues.

Aminatou Haidar expressed that the Award represents a powerful tool for the cause of Sahrawi people, and that it has and hopefully will continue to put pressure on the Moroccan authorities to stop the violations of human rights in the occupied territories of Western Sahara. She is planning to use the Award money for support to the work of various organisations in Western Sahara.

Objective 2: SUPPORT

The Foundation aims to give long-term support to its Laureates, assisting with personal security, bolstering their freedom and working conditions, and offering a safe network for mutual inspiration and support, as well as access to new contacts.

Specific objectives until 2020:

- The network provided by the Award for its Laureates is used by them frequently and has a significant impact on their work.
- The Laureates identify themselves more clearly with the Award.
- We have a good capacity to contribute to the protection of threatened Laureates, organising 1-2 protection missions per year and protection campaigns involving the UN system, giving protection grants, and being well prepared for emergencies.

The Right Livelihood House in Stockholm and the office in Geneva at Maison de la Paix are both established centres for active support to Laureates visiting Europe. Both places are assisting Laureates with meetings and events to highlight their work and extend their networks. The Geneva office is central for the Foundation's protection and advocacy work.

One way of connecting Laureates is to link them through an email group where they can share important information, petitions etc. During the year, 58 Laureates were active on this platform on around 20 different issues.

Overall, the Foundation had exchanges with 110 out of the now 178 Laureates – 32 on a low level; 30 on a medium level; and 48 on a high level (including meetings and/or more extensive exchanges). 47 Laureates have passed away since 1980. Eight of them were awarded together with their organisation, which the Foundation strives to stay in contact with. On top of this, the Foundation has also been in contact with 15 persons/organisations carrying on the legacy and work of deceased Laureates – 5 on a high level; 5 on a medium level; and 5 on a low level.

Stockholm office

Due to the Foundation's 40th Anniversary year, the Stockholm office worked with planning of the 3 conferences with local partners, to take part in the Spring of 2020.

Below, some events arranged in Stockholm (in addition to what was arranged for the new Laureates – see above) are listed:

- In early February, **Daniel Ellsberg** (USA, Right Livelihood Award 2006) visited Stockholm to receive the Olof Palme International Award. Ellsberg joined the

Fridays for Future Friday climate strike, the Foundation arranged a private meeting with **Greta Thunberg** (Sweden, receiving the Right Livelihood Award later in the year) in the Right Livelihood House, and a meeting with the Board which was in Stockholm for a Board meeting.

- On 28 March, Katharina Kiening from the **Robert Jungk** (Austria, Right Livelihood Award 1986) Library visited and had in-depth discussions with staff around our cooperation.
- On 17 September, in cooperation with Leopard Förlag (publishing house) and Amnesty International in Sweden, we arranged an event at Rival on the occasion of the release of **Edward Snowden's** (USA, Right Livelihood Award 2014) biography, *Permanent Record* (in Swedish: *I allmänhetens tjänst*) for around 300 guests. The Foundation's Executive Director, Ole von Uexkull, was featured live in connection to this in TV4 Nyhetsmorgon, Swedish Radio P4 Extra and Swedish Radio P4 Stockholm.
- On 25 September, around 75 representatives from Swedish civil society organisations mingled in the Right Livelihood House to celebrate the announcement of the 2019 Laureates.
- On 17 October, a dinner for more than 20 guests, among them two State Secretaries, Swedish MPs and Secretary Generals of major Swedish civil society organisations, was arranged in the honour of 1991 Right Livelihood Award Laureate MST, **The Landless Workers' Movement** (Brazil), represented by one of MST's national board members, Francisco "Toninho" Antonio Pereira.
- On 17 December, a group of 30 neighbours visited the Right Livelihood House and received information about the Foundation's work.

Geneva office

The support from the Swiss Agency for Development and Cooperation has, since 2015, made it possible for the Foundation to have an office in Maison de la Paix, Geneva. The cooperation with other organisations in the city mainly relates to our research, advocacy and protection work, but has been valuable also for arranging events for visiting Laureates, not least new Laureates each year in connection with the Award presentation in Stockholm.

In July 2018, the Foundation was granted the United Nations' Economic and Social Committee's (ECOSOC) special consultative status, giving the Foundation access to United Nations mechanisms, such as the Human Rights Council. This has made it possible for the Foundation to assist Laureates in contributing their expertise at an international level.

The Geneva office can also offer Laureates a working space, a venue for public events, and – for new synergies – meetings with the organisations sharing our office space:

- **International Baby Food Action Network, IBFAN** (International, Right Livelihood Award 1998);
- Center for Civilians in Conflict – CIVIC, working to develop and implement solutions to prevent, mitigate and respond to civilian harm in conflicts.
- Universal Rights Group, a think tank dedicated to analysing and strengthening global human rights;
- Aroha, working on climate, environmental and sustainability issues in relation to the world's most vulnerable people and regions. Supporting public and private partners with advice and direct assistance; and
- **Dr. Denis Mukwege** (Democratic Republic of Congo, Right Livelihood Award 2013) Foundation, dedicated to ending rape as a weapon of war worldwide.

In 2019, the Foundation reinforced its partnership with the Graduate Institute of International and Development Studies (IHEID) by launching a Right Livelihood section at the Library reserved to Laureates' books, which was inaugurated in December. The section which at this time had 400 books (also searchable online) from Laureates are thought to help spreading the Laureates' work particularly among students. Another cooperation between the two institutions is the Capstone Project (providing IHEID partners and students to engage in research projects "at the cutting-edge of global challenges"), where three students interviewed **Sima Samar** (Afghanistan, Right Livelihood Award 2012), **Raji Sourani** (Palestine, Right Livelihood Award 2013), **Jacqueline Moudeina** (Chad, Right Livelihood Award 2011), and a few women carrying on the legacy of **Dekha Abdi** (Kenya, Right Livelihood Award 2007) on peace and transition in post conflict situations, and also held a seminar on their report.

For Laureates visiting the Geneva office and engaging in various ways with International Geneva, please see below under advocacy.

Laureates at Risk

The Foundation has developed a programme for Laureates who are seriously threatened in their home countries as a result of the work they do. Most of the advocacy activities (below) focus on Laureates who are subjected to different kinds of threats.

The Foundation can provide protection grants if the life and security of Laureates are at risk. During 2019, 3 grants were provided.

Advocacy

Main activities - mainly in connection to Human Rights Council (Council) meetings:

Women Human Rights Defenders

On 28 February, the United Nations' Special Rapporteur on the situation of human rights defenders, Michel Forst, presented his report on the worsening global landscape for women engaged in human rights work. In response, the Foundation delivered an oral statement highlighting the situation of three female Laureates; **Mozn Hassan** (Egypt, Right Livelihood Award 2016); **Kasha Jacqueline Nabagesera** (Uganda, Right Livelihood Award 2015); and **Khadija Ismailova** (Azerbaijan, Right Livelihood Award 2017). In connection with the International Women's Day, the Foundation hosted a side event that brought together **Sima Samar** (Afghanistan, Right Livelihood Award 2012), **Ruth Manorama** (India, Right Livelihood Award 2006), Charlotte dos Santos Pruth from **Kvinna till Kvinna** (Sweden, Right Livelihood Award 2002), **Mozn Hassan** (Egypt, Right Livelihood Award 2016), and **Helen Mack** (Guatemala, Right Livelihood Award 1992). Throughout the year, the Foundation has been in continuous contact with UN Special Rapporteurs, sending letters of concern to denounce breaches of human rights affecting also **Aminatou Haidar** (Western Sahara, Right Livelihood Award 2019) and **Kasha Jacqueline Nabagasera** (Uganda, Right Livelihood Award 2015).

Democracy and Justice

On 23 September, the Foundation co-hosted an event with the Asian Legal Resource Centre where Basil Fernando (Hong Kong, Right Livelihood Award 2014) was one of the speakers, on the development of inclusive institutions by way of undeniable access to justice, and in upholding respect for democracy and the rule of law.

Health

In mid-November **Paul Walker** (USA, Right Livelihood Award 2013) participated in the Geneva Health Forum.

Egypt

On 3 July and 13 September, the Foundation voiced **Mozn Hassan's** (Egypt, Right Livelihood Award 2016) organisation Nazra for Feminist Studies' concerns, calling on Egypt to immediately lift the arbitrary and prolonged travel ban imposed on **Mozn Hassan** since June 2016, as well as the unfair freezing of her assets. On 13 November, on the occasion of Egypt's Universal Periodic Review, the Foundation, in partnership with Nazra, produced an advocacy paper with suggested recommendations.

Saudi Arabia

On 4 March, the Foundation co-hosted a side event on human rights abuses in Saudi Arabia and Human Rights Defenders' long sentences in prison, referring to **Abdullah Al-Hamid**,

Waleed Abu Al-Khair and Mohammad Fahad Al-Qahtani (Saudi Arabia, Right Livelihood Award 2018). The Foundation also delivered an oral statement, together with MENA Rights Group, during Saudi Arabia's Universal Periodic Review calling for the release of the Saudi Laureates and other political prisoners in the country. On 26 June, the Foundation joined 40 organisations calling on the Council to adopt a resolution to address ongoing human rights violations in Saudi Arabia. In mid-September, the Foundation called on the Council to draw its attention to the detention of the Saudi Laureates.

Turkey

On 1 March, the Foundation delivered an oral statement drawing attention to the dangerous environment for journalists in Turkey, and the criminalisation of dissent, specifically in the case of the newspaper **Cumhuriyet's** (Turkey, Right Livelihood Award 2016) reporters and staff.

Guatemala

On 19 March, the Foundation co-sponsored an event organised by Red Internacional de Derechos Humanos (RIDH) on corruption and impunity in Guatemala and in the region. **Iván Velásquez** (Colombia, Right Livelihood Award 2018) was one of the speakers. Velásquez also participated in a panel at the Geneva International Film Festival and Forum on Human Rights.

On 19 September, the Foundation delivered its third statement in response to the shutdown of the International Commission against Impunity in Guatemala (CICIG) by President Jimmy Morales. The Foundation urged the Council to closely and continuously monitor and protect human rights defenders and former staff of CICIG, including **Helen Mack** (Guatemala, Right Livelihood Award 1992) and **Iván Velásquez**.

Russia and Chechnya

In mid-March, the Foundation delivered an oral statement condemning the abhorrent treatment of human rights activists in Chechnya and other Northern Caucasus Republics, calling for the release of Oyub Titiev, former Chechnya head of **Memorial** (Russia, Right Livelihood Award 2004). In June/July, Tatiana Glushkova and Sergei Davidis, **Memorial** Human Rights Centre, visited Geneva and met with different UN Special Rapporteurs and a number of state delegations. On 1 July, the Foundation delivered a statement together with Memorial Human Rights Centre calling on the Council to attend to Russia's continuous refusal to abide by its international obligations.

Afghanistan

On 4 July, **Sima Samar**, then Head of Afghanistan's Human Rights Commission, addressed the Council through a video statement during the adoption of Afghanistan's Universal Periodic Review.

Democratic Republic of Congo (DRC)

On 19 September, the Foundation and the **Dr. Denis Mukwege** (Right Livelihood Award 2013) Foundation, together with other organisations, delivered a joint statement during the Universal Periodic Review adoption of the DRC, collectively calling for crucial institutional reform and strengthened efforts in prosecuting perpetrators of sexual violence crimes that are taking place within the state.

Palestine

In March, **Raji Sourani** (Palestine, Right Livelihood Award 2013) visited Geneva and spoke at an event organised by Palestinian organisation Al Mezan on Accountability and Human Rights in Gaza. He also met with diplomats to discuss the present human rights situation in Gaza.

Brazil

In October, Francisco Antonio Pereira of the **Landless Workers' Movement**, MST (Brazil, Right Livelihood Award 1991) met with three different Special Rapporteurs. The Foundation arranged a meeting with the OHCHR Brazil Desk Officer and representatives of civil society organisations with a focus on the use of pesticides and toxic wastes in North-Eastern Brazil. Pereira denounced the Brazilian government's policies against minorities, including indigenous peoples, and the violence occurring, often with links to authorities and big corporations.

Other support/networking

In February, the Foundation supported the third conference in a series arranged by **SAPPROS** (Nepal, Right Livelihood Award 2010) after the 2015 earthquakes that hit Nepal, with an aim of rebuilding Nepal in a sustainable way with a focus on renewable energy and organic agriculture. Board member Juliane Kronen participated.

In May, the Foundation arranged a 5-day programme in Berlin for 3 representatives of **The International Poetry Festival of Medellín** (Colombia, Right Livelihood Award 2006) working with their *Gulliver Project* - a project empowering children in difficult areas of Medellín through poetry and creative writing, also including information about human rights. They met with organisations in Berlin working on similar projects and issues, and also spoke at an event at the Nordic Embassies for around 75 people.

In mid-September, six Laureates were hosted by **SEKEM** (Egypt, Right Livelihood Award 2003) to discuss Solutions for Scaling up Agroecology. **Hans Herren** (Switzerland, Right Livelihood Award 2013), **Alyn Ware** (New Zealand - Aotearoa, Right Livelihood Award 2009), **Shrikrishna Uphadhyay**, SAPPROS (Nepal, Right Livelihood Award 2010), **Dipal Barua** (Bangladesh, earlier lead **Grameen Shakti**, Right Livelihood Award 2007), and **Tony Rinaudo** (Australia, Right Livelihood Award 2018) attended the meeting co-organised by **SEKEM** and

the World Future Council. The Foundation funded some of the Laureates' travel costs as part of the 'travel grants' scheme set up for the 40th Anniversary to connect Laureates on various topics.

Objective 3: EDUCATE

The Foundation aims to create opportunities, especially for young people, to learn from our Laureates' knowledge and experience about global problems and solutions.

Specific objectives until 2020:

- Our education programme continues to be implemented through partnerships, where most of the expenses do not go through our books, but the design and quality control lies with the Foundation.
- The Right Livelihood College (RLC) campuses have become even more active along the RLC core mission, significantly benefitting the Laureates. The number of campuses may have slightly increased, but most of all the intensity of activities at the existing campuses has increased substantially. The research done at the campuses is useful both for the Laureates involved and for other activists in the same field.
- We have developed a virtual college and a cooperation scheme with museums.
- We continue to make Right Livelihood Award content available to youth organisations, and we have started working with schools, e.g. giving stipends to talented students to lecture about the Right Livelihood Award in schools.

During 2019, the Foundation took important steps forward to take its work on education to a new level. After the strategic decision in 2018 to focus on connecting activism and academia through the Right Livelihood College network, in 2019 the Foundation entered new promising cooperations with the Global Campus of Human Rights and the University of Zurich, Switzerland. With the first full-time position dedicated to education activities, the Foundation increased its capacity to engage proactively in unfolding the potential of bringing together Laureates, researchers, and students in the future.

The Right Livelihood College

Students and researchers are given the possibility to study the work of Laureates through the nine Right Livelihood College campuses at leading universities on five continents. The Right Livelihood College is an affiliated member of the International Association of Universities, a UNESCO-based worldwide association of higher education institutions. Funds for these activities are raised by the participating university institutions themselves.

Below, some of the activities during 2019:

- On 2 March, **Iván Velásquez** (Colombia, Right Livelihood Award 2018) spoke on "A successful experience in the fight against corruption in Guatemala" at UCSC Bioneers Conference at the RLC Campus Santa Cruz.
- On 25 March, RLC Campus Bonn organised a public screening of the documentary, "The Man Who Stopped the Desert", followed by a discussion with **Yacouba Sawadogo** (Burkina Faso, Right Livelihood Award 2018).
- From 20–24 April, two students from RLC Campus Valdivia participated at a research-action programme at the RLC Campus Córdoba.
- From 29 April–3 May, RLC Campus Lund organised the Civil Society and Sustainability Studies (CIVICSUS) workshop, bringing together **Nnimmo Bassey** (Nigeria, Right Livelihood Award 2010), civil society actors and an interdisciplinary team of researchers, educators and students from RLC Campus Port Harcourt, RLC Campus Mumbai and RLC Campus Bonn.
- From 6–10 May, RLC Campus Lund together with the Land Institute and **Wes Jackson** (USA, Right Livelihood Award 2000) organised a conference on the future of perennial agriculture. RLC Campus Bonn also participated.
- 17 May, RLC Campus Valdivia organised "Dialogues on a Human Scale" with **Manfred Max-Neef** (Chile, Right Livelihood Award 1983) and **Juan Pablo Orrego** (Chile, Right Livelihood Award 1998).
- From 26–29 May, RLC Campus Bonn organised a workshop with **Helen Mack Chang** (Guatemala, Right Livelihood Award 1992) and international PhD students on "Mobilisation for Change: Marginalised people and their access to opportunities and resources", linked to the Global Media Forum of Deutsche Welle. Mack Chang participated in the DW TV show "Sociedad civil: ¿amplificada por las redes?", aired all over Latin America and North America.
- From 28–29 May, RLC Campus Port Harcourt organised its Fifth Annual RLC Lecture with **Ruth Manorama** (India, Right Livelihood Award 2006), **Raúl Montenegro** (Argentina, Right Livelihood Award 2004) and **Nnimmo Bassey** (Nigeria, Right Livelihood Award 2010) on the topic of "Global Environmental Politics, Human Rights and Conflict". Over 600 people from various professional backgrounds attended.
- On 3 July, RLC Campus Bonn organised a public panel with Jumanda Gakelebone, **First People of the Kalahari** (Botswana, Right Livelihood Award 2005), **Biovision Africa Trust** (Kenya, **Hans Herren/Biovision**, Right Livelihood Award 2013) and RLC Campus Port Harcourt, on "Alternative Development Pathways in Africa".
- From 7–22 July, RLC Campus Bangkok organised its 5th CURLS Summer School linked to the Earth Trusteeship Forum. **Anwar Fazal** (Malaysia, Right Livelihood Award 1982), **Raúl Montenegro** (Argentina, Right Livelihood Award 2004) and **Sulak Sivaraksa** (Thailand, Right Livelihood Award 1995) participated.

- From 22–24 July, RLC Campus Mumbai hosted a workshop with **Alyn Ware** (New Zealand, Right Livelihood Award 2009), RLC Campus Port Harcourt, and RLC Campus Bangkok, on “Development, Conflicts and Livelihood Security: A Dialogue”.
- In August, RLC Campus Santa Cruz visited the Campuses in Valdivia & Córdoba.
- On 22 August, RLC Campus Valdivia continued the “Dialogues on Human Scale” on the subject of “Extractivism and Solidarity Economy: Challenges of the 21st Century” with **Juan Pablo Orrego** (Chile, Right Livelihood Award 1998) and RLC Campus Santa Cruz.
- From 15–18 September, RLC Campus Bonn organised a workshop and public panel with **Tony Rinaudo** (Australia, Right Livelihood Award 2018) and **Wangari Maathai**’s (Kenya, Right Livelihood Award 1984) Green Belt Movement on “Greening the Future”.
- On 26 September, RLC Campuses Mumbai, Bangkok and Bonn organised a collaborative lecture on “The Housing Rights Movement”.
- On 1 October, RLC Campus Bonn started a three-year project on sustainable agriculture in Egypt together with **SEKEM** (Egypt, Right Livelihood Award 2003).

Global Campus of Human Rights

In May 2019, the Foundation and the Global Campus of Human Rights initiated a long-term cooperation to strengthening education, research, training, network-building and advocacy for the rights of children as stipulated in the UN Convention on the Rights of the Child and other similar instruments. **Nnimmo Bassey** (Nigeria, Right Livelihood Award 2010) spoke at the Global Campus’ graduation ceremony in Venice, **Sima Samar** (Afghanistan, Right Livelihood Award 2012) was part of the General Assembly presentation of the UN Global Study on Children Deprived of Liberty in New York, and **Jacqueline Moudeina** (Chad, Right Livelihood Award 2011) joined the regional launch of the same report in Pretoria, South Africa. Staff from the Global Campus of Human Rights were heavily involved in the coordination, writing and editing of the Global Study, and are in the lead of its dissemination and follow-up activities.

Objective 4: INFORM

The Foundation aims to make the Award and its Laureates better known internationally. Our Laureates have solutions to the most urgent global challenges – and the Foundation is there to help them get their message across.

Specific objectives until 2020:

- To significantly increase brand awareness by establishing the Award as an internationally recognised pre-eminent prize in its own right, without over-reliance on the 'Alternative Nobel'.
- To strengthen the Laureates' self-identification as Award recipients, prominently mentioning it on their websites, social media, biographies and in media interviews.
- To develop and effectively utilise digital channels, including website and social media, and to embrace future technological developments in communicating about the Award and its Laureates.
- To achieve high-quality, positive, year-round international media coverage that contributes to the visibility of the Award and its Laureates.
- To strengthen the communications capacity within the Foundation.

Strengthening Digital Presence

We have seen a general increase of followers/users of the Foundations' social media channels and website for the past year and an increase in impression/engagement, except for Facebook. Since June 2019, the Foundation has a new social media analytics tool from Sprout Social in place to better track and streamline updates on our social media channels. In August 2019, we transitioned our handle from @rlafoundation to @rightlivelihood across all channels to align better with the Foundation's name.

Social Media

As of December 31, 2019, the Foundation has 24 139 individual followers across four channels (Twitter, Facebook, LinkedIn, Instagram), with a net follower growth of around 3 980:

We had a total impression of 2.8M (+7 %) and total engagement of 93.6K (+27 %) for updates at @rightlivelihood on the four channels. We published 996 updates (+22 %) in the past year.

During the week of the announcement of new Laureates, the hashtag #RightLivelihoodAward had 8 million reaches (13.2 million in 2018). #AlternativeNobel had 168 million reaches (the Award is often referred to as "The Alternative Nobel Prize"). Hashtags in Spanish and German combined had 17 million reaches in total during that week. During the evening of the Award Presentation, #RightLivelihoodAward was trending 2nd on Twitter in Sweden.

The livestream (and recording) of the Announcement was viewed by 2 100 on YouTube, 646 on Facebook and 360 on Twitter. The Award Presentation in Stockholm was viewed by 3 384 on YouTube and 1 450 on Twitter. Expressen.se broadcast the Award Presentation, reaching more than 200 000 viewers. The video about the new Laureates had 52 300 views across all our platforms.

Website

The Foundation's website www.rightlivelihood.org had about 557 700 pageviews during the year (+17 % since 2018) and 229 300 (+16 %) unique pageviews. The number of users was 115 900 (+19 %). The Foundation implemented landing pages in other languages (Spanish, German & Swedish).

Newsletters

The number of subscribers to the Foundation's newsletter is unchanged at 2 500. A new layout was implemented in September.

Media Impact

2019 was a record year in terms of media reports mentioning the Right Livelihood Award and Foundation: more than 16 400 reports were published in the media during the year, which is 60 % higher than the previous record year in 2016 and over 150 % higher than in 2018 (2018: 8 300, 2017: 6 270, and 2016: 10 200). Top languages: German (7 400), English (3 500), Spanish (1 800), Japanese (670) and Swedish (640).

The significant increase of media coverage can be linked to the fact that the Swedish climate activist **Greta Thunberg** was bestowed with the Award. The media followed her actions closely during 2019, and there was a grand/great? interest in her becoming a Laureate.

Long reports, mainly about the 2019 Laureates, were featured in Democracy Now!, TV5Monde, Deutsche Welle, Le Monde, The Guardian, Spiegel Online, Washington Post, and El Mundo, to name a few. Democracy Now! aired its daily news programme from Stockholm three days in a row, in connection to the Award Presentation. The 2019 Laureates, representatives of the Foundation and several Laureates from previous years were featured in long interviews in the programme.

The Foundation's communications team worked year-around to encourage the media to cover the work and perspectives of Laureates. In February, **Daniel Ellsberg** (USA, Right Livelihood Award 2006) and **Paul Walker** (USA, Right Livelihood Award 2013) were featured in substantive interviews in both German and Swedish TV, commenting on the decision taken by the American President Donald Trump to suspend the US compliance with the Intermediate-Range Nuclear Forces Treaty. The same month, Al Jazeera aired a report about the Foundation's open nomination process and the call for proposals for candidates to receive the Award.

During the fall, the Foundation announced a new prize figurine, designed by world renowned sculptor Tony Cragg and made from melted illegal guns. Swedish TV4 made several reports about the new prize figurine and the issues around illegal weapons globally.

On 3 December, Aftonbladet.se published an op-ed signed by 9 Fridays for Future activists and the Foundation's Executive Director.

GOVERNANCE AND ADMINISTRATION

Specific objectives until 2020:

- The administration remains lean and efficient.
- Board rotation leading to optimum combination of experience and new perspectives.

Staff

The team grew in both Stockholm and Geneva during the year. The Foundation had 5 trainees, usually over a period of 6 months, but sometimes prolonged for another 6 months. The Foundation also had 3 volunteers assigned to specific tasks, and 3 international communications consultants.

See notes 3 and 4 for further details.

Board

The Board of the Right Livelihood Award Foundation consisted of six members (4 women and 2 men) from Sweden, the United Kingdom, Germany and the USA. Agneta Johansson resigned from the Board and was replaced by Gunilla Hallonsten on 3 February. The Board members as per the end of the year are listed below.

The Foundation's Board held its meetings on 3 February and 10 May in Stockholm, and on 29 August and 1 September in Merlischachen, Switzerland. Board members do not receive remuneration for fulfilling their Board duties. For a limited number of days, honoraria are paid when Board members carry out additional work, relating to the selection process and support to Laureates. For further information, see note 3.

The Foundation also has an Advisory Board with 11 experts in Sweden and Switzerland (6 women and 5 men).

SUPPLEMENTARY INFORMATION

Accounting Principles

Applied accounting and valuation principles are in accordance with the Swedish Annual Accounts Act (Årsredovisningslagen), statements and general advice by the Swedish Accounting Standards Board (Bokföringsnämnden) and FRIL's guidelines. The K3 rules are applied and followed.

Receivables

Receivables are valued at the amount with which they are expected to be settled.

Tangible Fixed Assets

Land and Buildings

The acquisition value has been distributed on land and building based on the tax assessment value of 2015. The assessed value of the buildings has then been analysed and distributed on components for depreciation purposes. The renovations in 2018 and 2019 have been handled in the same way. The buildings are depreciated in between 10 years and 70 years. Land improvements are depreciated in 20 years.

Equipment

Equipment is depreciated in 5 years. Computers are depreciated in 3 years. Equipment and computers at a value of up to a half price base amount are expensed directly.

Financial Fixed Assets

The foundation's assets are as in previous years valued at the market value at the balance sheet day. Realised and unrealised changes in value are accounted for in the income statement under financial items.

Taxes

The Right Livelihood Award Foundation is under the Swedish Income Tax Law (inkomstskattelagen) (1999:1229) chapter 7 § 17 liable for tax only on income from real estate holding.

Donations

Donations are accounted for in the period in which the donation is handed over and then at the actual value. Donations in other forms than ready money are valued at market value at the day of donation.

Capital donations are donations aimed at building up the Foundation's capital to the level where the work can be planned more long term and make possible a broader range of activities for the Laureates. Capital donations are balanced directly to the equity.

Purpose determined donations and grants are initially accounted for under a separate item under equity and transferred to income as the activities financed by the grant are carried out.

Report on the annual accounts

Opinions

We have audited the annual accounts of Right Livelihood Award Stiftelsen for the financial year 2019-01-01 - 2019-12-31.

In our opinion, the annual accounts have been prepared in accordance with the Annual Accounts Act and present fairly, in all material respects, the financial position of the foundation as of 31 December 2019 and its financial performance and cash flow for the year then ended in accordance with the Annual Accounts Act.

Basis for Opinions

We conducted our audit in accordance with International Standards on Auditing (ISA) and generally accepted auditing standards in Sweden. Our responsibilities under those standards are further described in the *Auditor's Responsibilities* section. We are independent of the foundation in accordance with professional ethics for accountants in Sweden and have otherwise fulfilled our ethical responsibilities in accordance with these requirements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinions.

Responsibilities of the Board of Directors

The Board of Directors are responsible for the preparation of the annual accounts and that they give a fair presentation in accordance with the Annual Accounts Act. The Board of Directors are also responsible for such internal control as they determine is necessary to enable the preparation of annual accounts that are free from material misstatement, whether due to fraud or mistakes.

In preparing the annual accounts, The Board of Directors are responsible for the assessment of the foundation ability to continue as a going concern. They disclose, as applicable, matters related to going concern and using the going concern basis of accounting. The going concern basis of accounting is however not applied if the Board of Directors intends to liquidate the foundation, to cease operations, or has no realistic alternative but to do so.

Auditor's responsibility
